Atlas Corps also partners with other organizations to implement international exchange programs that complement Atlas Corps' mission to develop leaders, strengthen organizations, and promote innovation. The scheme was detected, however it was too late to recall the wire transfers, and Atlas Corps lost the total amount of the wire transfers. Lack of professional skepticism by the Finance Director and failure to follow policies and procedures that Atlas Corps has in place to mitigate risks of unauthorized wire transfers were key contributing factors. The Finance Director resigned voluntarily shortly after the event. Atlas Corps immediately put in place new procedures and bank security protocols to strengthen controls in this area.
